

REGISTRATION PRIVACY POLICY

Dear User,

We inform you that EU Regulation 2016/679 governs the processing of Personal Data of natural persons. In accordance with this Regulation, the processing will be carried out based on the principles of lawfulness, fairness, transparency and protection of your Personal Data and rights.

DATA CONTROLLER

PURPOSE OF THE PROCESSING

The processing of your personal data is necessary for the creation of a personal account on our website.

LEGAL BASIS OF THE PROCESSING

The legal basis for the processing is the consent you provide in relation to the purpose specified above.

CONSEQUENCES OF FAILURE TO PROVIDE PERSONAL DATA

Providing your personal data for the purposes indicated above is not a contractual obligation. However, failure to provide such data will make it impossible to create your personal account.

CATEGORIES OF PERSONAL DATA PROCESSED

In particular, the categories of personal data we may process include:

WHO WE MAY SHARE YOUR PERSONAL DATA WITH

Your personal data will be processed by our staff using both IT and paper-based tools and will be protected at every stage of processing through the adoption of appropriate security measures.

PLACE OF PROCESSING

All processing activities will take place within the European Economic Area (EEA), primarily at the premises of the Data Controller. Except for disclosures required by legal or contractual obligations, personal data will not be transferred to countries outside the European Union.

DATA PROCESSORS

External parties appointed as Data Processors may include, but are not limited to:

- ☐ Professionals or service providers responsible for the management and maintenance of the website, acting on behalf of the Data Controller.

METHODS OF PROCESSING

This Policy applies to the personal data provided by the user (technically: the data subject) during the registration process for account creation. In accordance with Article 5 of the GDPR 679/2016, your personal data will be processed lawfully, fairly and transparently; collected for specified, explicit and legitimate purposes; and processed in a manner

compatible with those purposes. The data will be adequate, relevant, and limited to what is necessary; accurate and, where necessary, kept up to date; stored in a form that permits identification of data subjects; and processed in a manner that ensures appropriate security, including protection against unauthorized or unlawful processing and against accidental loss, destruction, or damage, using suitable technical and organizational measures.

DATA RETENTION PERIOD

Personal data will be retained only for as long as necessary to fulfill the purposes for which they were collected, or until a request for erasure is submitted by the data subject.

RIGHTS OF THE DATA SUBJECT

Data subjects have the rights set out in Articles 15, 16, 17, 18, 20 and 21 of the GDPR, including the right to access their personal data, request rectification or erasure, restrict processing, and exercise data portability.
